ARTICLES OF ASSOCIATION (AD)

Bismillaahir rahmaanir rahiim

MUKADDIMAH

The truth is that knowledge and wisdom come from Allah SWT as the main gift given by Allah to the chosen human race. CHAPTER I

NAME, PLACE, TIME AND SYMBOL OF THE ORGANIZATION

Article 1 Name

This organization is called the Indonesian Islamic Economists Association abbreviated as IAEI.

Article 2 Place and Time of Establishment

IAEI was established at the National Convention of Islamic Economists at the Palace of the Vice President of Indonesia (Republic of Indonesia) in Jakarta, on March 3 - 4, 2004 for an indefinite period.

The symbol and / or logo of the Indonesian Islamic Economists Association consists of black IAEI writing which means simple and firm. The writing bismillahirrahmanirrahim means that in starting all activities, IAEI always asks for help, protection and guidance from Allah, the Most Merciful and Compassionate, the image of the rising sun means that the Islamic economy will shine all the time to provide light to the Indonesian economy and the dome of the mosque means that all economic activities are shaded by sharia.

The formation of Islamic economists who are more knowledgeable, charitable and devoted to the development of science, profession and implementation of Islamic economics in the life of society, nation and state, and are responsible for the realization of a just and prosperous society that is blessed by Allah SWT.

CHAPTER III VISION AND MISSION

Article 7 Vision

The vision of the Indonesian Islamic Economists Association is to become a forum for Islamic economists who are committed to developing and implementing sharia (Islamic) economics in Indonesia.

Article 8 Mission

- (1) Make a real contribution to the government both constructive thinking and real action in the development of an equitable Indonesian economy.
- (2) Prepare qualified Indonesian human resources in the field of Islamic economics and finance through educational institutions and training activities.
- (3) Building synergy between Islamic financial institutions, educational institutions and the government in grounding Islamic economics in Indonesia.
- (4) Build networks with international institutions, including financial institutions, research and international investor organizations.

Article 11

Activities

- (1) Advancing Islamic economics through the study and research of various creative potentials for the development and implementation of Islamic economics, both nationally and internationally.
- (2) Improve and develop the scientific capacity and professionalism of human resources of members through seminars, workshops, conferences, training and so on, both nationally and internationally.
- (3) Conducting policy development efforts through legislation, channeling aspirations and suggestions to state institutions or community organizations to advance and develop Islamic economics, both at the regional, national and international levels.
- (4) Cooperate with other institutions and/or organizations, both at home and abroad to advance and develop Islamic economics.
- (5) Encourage and support IAEI members who have the capacity, capability and acceptability and have trustworthy personality integrity to hold strategic public positions to advance the Islamic economy.
- (6) Continuous efforts to socialize the Islamic economic system through various media, education and training.
- (7) Building a forum for friendship, dialogue and cooperation between scholars, academics, observers, and Islamic economic actors to advance and develop Islamic economics.
- (8) Make other efforts in order to achieve organizational goals.

CHAPTER V POSITION, SOVEREIGNTY AND ORGANIZATIONAL STRUCTURE

Article 12 Position

- (1) The IAEI organization is domiciled in the Republic of Indonesia.
- (2) Representatives of IAEI organizations can be opened in all countries of the world.

Article 13
Sovereignty

The supreme sovereignty of the organization is in the hands of the management of all levels carried out through the Muktamar.

Article 14 Structure

- (1) IAEI's organizational structure consists of:
 - (a) The Central Leadership Council (DPP) is the highest organization at the central level and is based in the national capital.
 - (b) The Regional Leadership Council (DPW) is the organization at the provincial level.
 - (c) The Regional Leadership Council (DPD) is an organization at the district and or municipal level.
 - (d) The Commissariat Committee (PK) is an organizational unit at the district and or municipal level that can be formed by educational institutions or practitioners.

(2) The structural relationship between the Central Leadership Council, Regional Leadership Council, Regional Leadership Council and Commissariat Management is regulated in the Bylaws.

Article 15 Organization Leaders

Organizational leadership consists of the Central Leadership Council, Regional Leadership Council, Regional Leadership Council, and Commissariat Management.

CHAPTER VI DELIBERATION

Article 16

- (1) Consultation is the organizer of the organization's membership mechanism, which is:
 - (a) Muktamar
 - (b) Extraordinary Congress
 - (c) DPP Work Meeting
 - (d) National Work Meeting
 - (e) Regional Conference
 - (f) Extraordinary Regional Conference
 - (g) Regional Work Meeting
 - (h) Regional Conference
 - (i) Regional Work Meeting
 - (j) Extraordinary Regional Conference
 - (k) Commissariat Meeting
 - (1) Commissariat Work Meeting
 - (m) Extraordinary Commissariat Meeting
- (2) Matters relating to decision-making will be further regulated in the Bylaws.

CHAPTER VII TERM OF OFFICE

Article 17

- (1) The term of office of the IAEI Management is 4 (four) years
- (2) The position of General Chairperson at the Central Leadership Council, Regional Leadership Council, Regional Leadership Council and Commissariat Management level is for a service period of 2 (two) periods, and if it is to be re-elected for the next period it must be decided at the Muktamar level.

CHAPTER VIII VOTING AND SPEAKING RIGHTS

Article 18

Voting Rights and Speaking Rights in decision-making forums are regulated in the Bylaws.

CHAPTER IX FINANCIAL RESOURCES

Article 19

The organization's financial resources are obtained from:

- (1) Membership Fees
- (2) Member dues
- (3) Sadaqah, Hibah, Zakat, Infaq and Waqf (both from within and outside the country)
- (4) Other legal, halal and non-binding sources/efforts.
- (5) Donation / Infaq 30% of the honorarium of the resource person and from the results of the board's fundraising efforts in running the program (outside the general program of the DPP IAEI) on the basis of IAEI recommendations.
- (6) All incoming funds must go through the DPP IAEI account

CHAPTER X RATIFICATION OF THE ARTICLES OF ASSOCIATION

Article 20

- (1) The first ratification of these Articles of Association took place at the National Convention of the Association of Islamic Economists on March 3-4, 2004.
- (2) The ratification of these Articles of Association was then carried out at the IAEI I Congress on September 18-19, 2005 in Medan-North Sumatra, and can be updated/reviewed at each Congress.

CHAPTER XI AD/ART CHANGES

Article 21

Amendments to the Articles of Association and Bylaws can only be made at a Congress.

CHAPTER XII DISSOLUTION OF THE ORGANIZATION

Article 22

The organization can only be dissolved by a Congress or an extraordinary Congress specially convened for that purpose.

CHAPTER XIII ELECTION PROCEDURES

Article 23

- (1) The election of the Chairperson of Formation / General Chairperson for the next period can be carried out by acclamation, inauguration, direct appointment and / or election through the formation of a Formation Team.
- (2) The elected Chairman of the Formation / General Chairperson is determined by the Congress.
- (3) The Chairperson of Formation/Elected Chairperson forms the Formation Team.
- (4) The entire Central Executive Board is appointed by the Chairperson of Formation / Chairperson Elect.
- (5) The management of the Regional Leadership Council is determined by the Central Leadership Council.
- (6) The Regional Leadership Council is appointed by the Regional Leadership Council.
- (7) Commissariat administrators are appointed by the Regional Leadership Council.

CHAPTER XIV CLOSING PROVISIONS

Article 24

- (1) The Articles of Association and the Bylaws are inseparable from one another.
- (2) Matters that have not been regulated in these Articles of Association will be regulated in the Bylaws.
- (3) Other provisions that have not been covered in the Articles of Association and Bylaws will be further regulated by the IAEI Central Leadership Council as long as they do not conflict with the Articles of Association and Bylaws.
